



## 2018 Participant Registration

Welcome to Willow Creek Ranch, Inc.! WCR strives to provide a safe environment for all of our participants and requires all participants, families, guests and volunteers abide by our safety rules and policies. It is very important we receive your participant forms and fees as soon as you have been confirmed to participate at WCR. Participants will not be allowed to begin lessons without all required paperwork and fees turned in.

Our participant lesson fees represent only about 30% of what it actually costs to provide each client with the benefits of therapeutic riding. The other 70% comes from fundraisers and donations from various sources. If personal circumstances would allow you to pay more than our standard enrollment fee, adding any amount will help us fill the gap in funding. Please make a note of the additional donation on your check. It will be considered a donation and is tax deductible.

### **FEES**

**Previous participants from 2017:** There is a non-refundable registration and processing fee of \$20.00. No full evaluation/assessment is required, but a Goals form, in addition to other annually-required forms, must be completed and returned.

**New participants:** All new participants must have an evaluation with a PATH Intl. certified therapeutic riding instructor. Fee is \$35.00.

**Group Lesson:** the fee for one 6-week session is \$210.00. If paid in advance, the fee is \$180.00 for 45 therapeutic minutes.

**Private Lesson:** the fee for one 6-week session is \$270.00. If paid in advance, the fee is \$240.00 for 45 therapeutic minutes.

Therapeutic minutes are defined as interaction time that serves the purpose of improving the learning and growth of a rider, with horseback riding time a part of those therapeutic minutes. Lessons may include ground work.

**EFFECTIVE 2018:** All fees must be paid prior to the beginning of each session. Weekly payments will no longer be accepted. All required paperwork and full payment must be received one week prior to start of your session or your lesson time may be released to another participant. A Special: is offered for early payment.

Lessons falling on a holiday will be pro-rated or a make-up lesson, if time is available, may be scheduled within that session. *See WCR Policies for additional information on class cancellation*

You may register for each session separately or for the whole 2018 season. Payment due dates are indicated for each session.

NOTE: No classes will be held Monday, May 30, or Monday, September 3. A make-up lesson, if time is available, will be scheduled during the session or fee will be prorated after the session.

NOTE: Willow Creek Ranch will be CLOSED July 1 through July 8.
